

Also included are graphs showing a comparison of the destinations/feeder markets that we track within some individual state.







• The US has reported a record-high again, with a daily average of more than 196,000 cases over the last week.


- Researchers and experts caution against relying solely on any one metric, including positivity rate.
- For positivity rate to be more meaningful, a community would need to be testing a group of people representative of the entire community, not just those who feel sick or have confirmed exposure.

 Hospitalizations hit a new high with over 100,000 patients being in the hospital.





Feeder Markets: Western Region – New Cases

- Clark County (Las Vegas) was tagged for "elevated disease transmission for the 7th week in a row – current Clark County metrics contributing to this are 17,723 cases per 100,000 reported over the last 30 days and a 17.3% test positivity.
- L.A. reported its single day highest # of cases , >10,000, on Dec. 6.





Feeder Markets: Western Region – New Cases

 Seattle's apparent decline in cases may be due to a backlog of test results.

 Cases in New Mexico were down 11.5% from the previous week with Bernalillo County (Albuquerque) being one of the counties with the deepest decline.





- The Houston area represented more than 25% of Texas' new cases on Dec. 6.





Feeder Markets: Northeast, Midwest Regions – New Cases

- Chicago is down about 35% since the peak in mid-November.
- Michigan reports "fragile" progress from a 3-week pause in reopening, and extended the partial shutdown until Dec. 20.



Western Mountain Destinations – New Cases


- Teton (Jackson) recommends limiting gatherings only to household groups until Dec. 15.
- Cases in Montana fell in 28 counties with Flathead having one of the biggest declines.
- Steamboat saw the first decrease last week in new cases.



Western Mountain Destinations – New Cases

 Aspen (Pitkin County) will begin (Dec. 14) requiring a negative test result or a 10 day quarantine for all visitors planning to stay at least one night.

• Summit County CO's positivity rate increased 0.7% from the previous week.



Southeast Destinations – New Cases

- Bay County (Panama City Beach) percent positivity increased from 8.57 to 10.97% despite the addition of another testing site.
- Sat., Dec. 5 was the 4th day in a row that Horry County (Myrtle Beach) reported >100 new cases.
- Beaufort County (Hilton Head) reported 3 days of its highest daily case count since early August.





Southeast Destinations – New Cases

- Nashville's 14-day new case trend has begun a slight decline, while an 8person gathering limit went into effect on Dec. 7.
- New Orleans mayor says more restrictions will be put in place if numbers don't go down over the next week. Current positivity rate is 36%, roughly triple what it was a month ago.






- The # of confirmed COVID patients hospitalized in CO dropped dramatically last week for the first time in 2 months.
- After dropping for 4 days in a row, the percent of positive tests rose on Sunday, Dec. 6.


• Cases in Florida have climbed over the last 2 months but have not yet hit the peaks seen in the summer.


 Oregon had planned to begin "Fall" high school sports this month but has now delayed them until February due to rising case numbers.
